What is the background for the California Child Care Study?



#### A partnership between California state departments

- Funded by California Department of Social Services (CDSS)
- Conceived in partnership with California Department of Education (CDE)
- CDSS and CDE...
  - Oversee the contract with Child Trends
  - 2. Promote of the value of the study
  - 3. Serve as key decision makers







#### Who was consulted on the study design?

The Technical Advisory Group (TAG) is a workgroup composed of representatives from the following agencies:

- The CA Department of Social Services (CDSS)
- The CA Department of Education (CDE)
- The County Welfare Directors Association (CWDA)
- The CA Child Care Resource and Referral Network (CCR&R)
- County and Alternative Payment Provider Agencies
- Title 5 Early Education and Support Division (EESD) administered programs



#### What is Child Trends?

Child Trends is a nonprofit, nonpartisan research center that improves the lives and prospects of children and youth by conducting high-quality research and sharing the resulting knowledge with practitioners and policymakers.

What is the purpose of the study?



## Why is this study needed? Funding and management of child care in California is complicated.

CA Dept. of CA Dept. of **Social Services Education (CDE)** (CDSS) CalWORKs Stage Two, **CalWORKs** CalWORKs Stage Three, State Preschool, Migrant Stage One Child Care, General Child Care, Alternative Payment



#### California Child Care Subsidy Data

- Neither CDE nor CDSS oversee the collection and management of ALL child care subsidy data for the state of California.
- Some data are collected by local agencies or child care providers and are not shared with either CDE or CDSS.
- Comprehensive, up-to-date, information regarding families and children receiving child care subsidies is lacking.



#### What is the purpose of this study?

- 1) Use administrative, survey, and interview data to document agency, provider, and family characteristics.
- 2) Generate dataset and final report for use by the Departments of Social Services and Education to inform policy and program decision-making.

It will be the role of the California state departments to conduct interpretive analyses of the final dataset.



What is the design of the study?



#### Study Design Steps

- Develop a representative sample of families, providers, and children participating in CDE- and CDSS-funded child care programs
- Document characteristics of providers and families using administrative data collected by local child care agencies
- Conduct a survey with a representative sample of providers and families to fill in the gaps, generating a complete dataset



# What are the CDSS- and CDE-funded child care programs?

Child Trends will collect data for families, children, and providers participating in the subsidy program through the following state contracts:

- CalWORKs Stage One Child Care
- CalWORKs Stage Two Child Care
- CalWORKs Stage Three Child Care
- General Child Care and Development Programs
- Alternative Payment Programs (APPs)
- Migrant Child Care and Development Program & Migrant Alternative Payment Program
- California State Preschool Program (CSPP)



#### What is a "representative sample"?





#### Study process and timeline

- 1. Pilot testing of surveys: 2017
- 2. Develop survey sample: early 2018
- Collect administrative data: early 2018
- 4. Communication and recruitment activities: early/mid-2018
- 5. Field provider survey: early 2018 fall 2018
- 6. Field family interview: spring 2018 fall 2018
- 7. Generate final data set: Jan-Mar 2019



What will study participants do?



# Three primary groups of research participants & their activities

- Agencies
  - Provide administrative data
- Providers
  - Participate in a 30-minute web or phone survey
- Families
  - Participate in a 30-minute phone interview



All participation is voluntary



#### Agency Data Collection

- Once we have selected providers and their associated agencies, we will collect administrative data.
- Data elements will include:
  - Family characteristics
  - Payments to providers
  - Family fees and copayments
  - Notice of Action (NOA) issued by agencies administering subsidies



#### Provider Online Survey

- Participants
  - Center-based, home-based, and license-exempt providers are eligible
- Timeline
  - Fielding starts early 2018, concludes fall 2018
- Data collection method
  - Website or phone
  - English, Spanish, other languages
- Incentives
  - +40 gift card
- Contact organization
  - Conducted by IMPAQ International



# What types of questions are in the provider survey?

- Primary areas of interest include:
  - Provider demographics (e.g., age, race/ethnicity, education level)
  - Use of developmental screening tools
  - Support for children with unique needs (e.g., those with an IEP)
  - Staff education levels
  - Staff training



#### Family Interview

- Participants
  - -Up to 3 families from each participating provider
- Timeline
  - -Fielding starts spring 2018, concludes fall 2018
- Data collection method
  - –Phone
  - English, Spanish, other languages
- Incentives
  - -\$25 gift card
- Contact organization
  - -Conducted by Brian Fitzgerald



# What types of questions are in the family interview?

#### Primary areas of interest include:

- Payments made for child care
- Parent demographics (e.g., age, education, race/ethnicity, primary language)
- Family income & other need criteria
- Duration of subsidy receipt
- Utilization of care
- Family's experience of subsidy system(s)



#### Assurances

- All data are de-identified
  - Data matched according to ID numbers
- Child Trends, IMPAQ, and Brian Fitzgerald take data security very seriously
  - MOU with CDE & CDSS
  - Data security training
  - Secure server
- Participation is voluntary
  - Providers and families consent to participate
